Annual Volunteer Renewal Process

Jenae Hansen-Gross, SD 4-H Volunteer Development and Civic Education Field Specialist South Dakota 4-H volunteers are essential to the mission of our program. These caring adult mentors bring forth many skills and hours of dedicated service each year to help strengthen the lives of young people. If you were a volunteer in the 2024-2025 4-H program year, thank you so much!

South Dakota 4-H volunteers serve one-year terms, renewable indefinitely so long as both parties (i.e., typically the volunteer and lead county 4-H professional) wish to continue the relationship. The returning volunteer indicates this interest by re-enrolling in 4-HOnline after October 1st. At this point, the returning volunteer's status is "pending." In most cases, the lead local 4-H professional will quickly approve and the 4-HOnline status will then say "active." This signifies the renewal of the relationship for the 4-H year ahead.

If the lead local 4-H professional does not wish to continue the relationship or wishes to discuss role restrictions or alterations, they will communicate this to the volunteer. Each year, a few 4-H volunteers are not renewed for service.

Reminder: All returning volunteers need to indicate their interest in returning. The preferred renewal date is before December 31(or other local program preferred date), but required before volunteers are allowed to do any 4-H programming or events and before September 1st. Otherwise, should they wish to return at a future time, they will have to restart the volunteer process from scratch and pay a \$75 lapsed background check fee.

- Show isopen to the World; minimum 4-Hage to 21 yrs of age
- Entry fee--\$30 per calf entered, due at check-in or preregistration
- Pre-registration will occur on the Showman app. <u>Not</u> required, but encouraged. MC 4-H entries are due Nov 24
- Steers will be split by breed and then weight (declared weights, scale available)
- Heifers are split by breed and then by age with fall heifers born in 2024 eligible to show per SDJPS rules. All other calves must be born in 2025
- This show will be divided according to sanctioned rules. The British division is for British Straight Breeds only
- Registration papers/means to acquire papers are encouraged for all breeds or you are subject to show commercial
- Calves entered must be accompanied by current health
- All exhibitors must check-in at 4-H building before unloading trailers. Declare weights at check-in (scale available on site)
- Fitting is optional: no washing facilities available
- All decisions of Show Committee and Judge will be final; Judge
- may call for weight check at his/her discretion
- Calf Show Committee will not be responsible for accidents and exhibitors enter at their own risk
- All bedding must be cleaned up or forfeit premiums--a manure bunker is available on the south end of grounds
- Weather updates will be posted to the Miner County Feeder
